In exercise of the powers conferred under Clause 10 of the U.P. Restriction on sugarcane Purchase Order, 1966, I.G.C. U. P. VACUUM PAN SUGAR FACTORIES LICENSING ORDER, 1969

English translation of Udyog (Ga) Vibhag, Notification No. 6941-S/xviiic 1517-57, dated January 15, 1969, published in U.P. Gazette, Extra-ordinary, dated 15th January, 1969, pp. 6-11.

Whereas the power to regulate production of sugar by the Vacuum Pan Sugar Factories exercisable by Central Government under Clause 3 of the Sugar Control Order, 1966, has been delegated to the State Government under clause 15 of the said Order by the Ministry of Food and Agriculture, Community Development and Co-operative "Department of Food", Government of India, Notification No. G.S.R.-129/Ess-Com. Sugar, dated August 24, 1967.

And, whereas, the State Government is of the opinion that it is necessary and expedient so to do for regulating production of Sugar by the Vacuum Pan Sugar Factories.

Now, therefore, in exercise of the powers delegated to the State Government as aforesaid, and in supersession of the existing orders on the subject, the Governor of Uttar Pradesh is pleased to make the following order.

- 1. Short title, extent and commencement.—(1) This order may be called the U.P. Vacuum Pan Sugar Factories Licensing Order, 1969.
 - (2) It extends to the whole of Uttar Pradesh.
 - (3) It shall come into force at once.
- 2. Definitions.—In this order unless the context otherwise requires:
 - (a) "Producer of Sugar" means a person carrying on the business of manufacturing sugar by vaccum-pan process;

- (b) "Occupier" or "occupier of a factory" means the person, who or the authority which, has the ultimate control over the affairs of the factory and where the said affairs are entrusted to a Manager, Managing Director or a Managing Agent, such Manager, Managing Director or Managing Agent shall be deemed to be the occupier of the factory;
- (c) Sugar Commissioner—Means an officer appointed as Sugar Commissioner by the State Government;
- (d) Licence—Means a licence granted under the provision of this order;
- (e) "Schedule" or "Form"—Means a "Schedule" or "Form" appended to this order;
- (f) Licensing year—Means, the period beginning on the 1st date of July in any year and ending on the 30th June next following:
- (g) State Government—Mean the Government of Uttar Pradesh.
- 3. Grant of Licence.—(1) No Sugar shall be manufactured from sugar-cane by a producer of sugar by vacuum pan process unless he has obtained from the State Government a licence therefor in the form prescribed in Schedule 1.
- (2) An application for grant or renewal of a licence under sub-clause (1) shall be submitted to the Sugar Commissioner by the date prescribed in Schedule II in the form prescribed in Schedule III and accompanied by a satisfactory proof of the fee prescribed in Schedule IV :

Provided that the State Government may renew the licence for which an application for renewal is received after the expiry of the prescribed date for receipt of such an application, if State Government is satisfied that there was reasonable cause for the delay.

- 4. Period for which licences to be issued.—A licence granted or renewed under this order shall be subject to the conditions prescribed in the form of licence set out in Schedule I and shall be valid for the entire licensing year or any part thereof as indicated in the licence by the State Government.
- 5. Issue of duplicate licence.—If a licence granted under this order is defaced, lost or destroyed, duplicate thereof may be obtained from the Sugar Commissioner on application accompanied by a satisfactory proof of the payment into Treasury of Rs. five only.
- 6. Conditions for suspension or cancellation of licence.—(1) The State Government may without prejudice to any other action that the State Government may be authorised to take under this order, cancel or suspend any licence if the licensee has contravened any provision of this order or any condition of his licence.
- 7. Powers of the Sugar Commissioner.—The Sugar Commissioner or any person authorised by him with a view to securing compliance of the provisions of this order—
 - (a) require any producer of sugar or occupier of a sugar factory to give any information in his possession in respect of any process connected with the producer of sugar by vacuum pan process:

- (b) require licensee to maintain, or to produce such records, dates or information as may be necessary from time to time;
- (c) inspect any books or documents and stock of sugar belonging to or in control of any person in respect of which he has reason to believe that contravention of any provision of this order has taken place or as likely to take place and may take such books or documents into his possession for examination or security.
- 8. Penalties.—If a person contravenes any of the provisions of this order or conditions of the licence he shall be punishable in accordance with the provisions of the Essential Commodities Act, 1955.

THE UTTAR PRADESH KHANDSARI SUGAR (LEVY) ORDER, 1975¹

(See Rule 114 of the Defence of India Rules, 1971)

Whereas the State Government is of opinion that it is necessary and expedient so to do for securing equitable distribution of Khandsari sugar and its availability at faire price.

Now, therefore in exercise of the powers under sub-rule (2) of Rule 114 of the Defence of India Rules, 1971, and with the prior concurrence of the Central Government, the Governor, is pleased to make the following order, namely:—

- 1. Short title, extent and commencement.—(1) This order may be called the Uttar Pradesh Khandsari Sugar (Levy) Order, 1975.
 - (2) It extends to the whole of Uttar Pradesh.
 - (3) It shall come into force at once.
- 2. Definitions.—In this Order, unless the context otherwise requires—
 - (a) "Controller" means the District Magistrate of the district, and include such officer not below the rank of a District Supply Officer as may be authorised in writing by him to perform all or any of his functions as Controller under this Order;
 - (b) "Specified price" in relation to Khandsari sugar required to be sold to the State Government under Clause 3, means 2[two hundred thirty five rupees] per quintal of Khandsari sugar packed in standard gunny bags, and includes charges on transport of Khandsari sugar from the place of manufacture up to the purchase centre and all other incidental charges but does include any duty or tax, if any, paid or payable on such Khandsari sugar;

- (c) "Enforcement Officer" means the District Magistrate or any magistrate subordinate to him, Regional Food Controller, Deputy Regional Food Controller, Regional Marketing Officer, District Supply Officer, Area Rationing Officer, Tehsildar, a police officer not below the rank of an Assistant Sub-Inspector, Commissioner or Additional Commissioner or Deputy Commissioner or Assistant Commissioner of Food and Civil Supplies, Uttar Pradesh;
- (d) "Khandsari Sugar" means while crystalline sugar containing more than ninety per cent sucrose and manufactured at a sulphitation unit by open process including a Bel;
- (e) "Levy share" with its cognate expressions and grammatical variation, means such quantity of Khandsari sugar as the producer is required to sell to the State Government under Clause 3:
- (f) "producer" means a person carrying on the business of manufacture of Khandsari sugar:
- (g) "purchasing centre" means a place declared as such by the Controller:
- (h) "release certificate" means a certificate granted in the form given in the Schedule by such officer as may be specified by the Controller by order in that behalf to the producer in token of his having sold the required quantities of Khandsari sugar to the State Government;
- (i) "Schedule" means the schedule appended to this order;
- (1) "State Government" means the Government of Uttar Pradesh;
- (k) all other expressions used but not defined in this order shall have the same meanings as in the Uttar Pradesh Khandsari Sugar Manufacturers Licensing Order, 1967.
- 3. Levy on Khandsari Sugar.—(1) Every producer shall sell to the State Government at the specified price at a purchasing centre ¹[one fourth] of the Khandsari sugar manufactured by him in the first process.

Explanation.—No levy shall be due on the sugar manufactured in the second or any subsequent process.

- (2) For the purposes of sub-clause (1),
- (a) the quantity of Khandsari sugar manufactured in the first process by a producer ²[using hydraulic crusher] shall be deemed to be 4-1/2 percent of the sugarcane crushed by him; [***]³.
- 4[(aa) the quantity of Khandsari sugar manufactured in the first process by a producer using non-hydraulic crusher shall be 4 per cent of the sugarcane crushed by him; and)
